History

Mr. G.W. (Bill) Harris, a long-time Mission resident and former Mayor, recognized the need for an organization where Mission residents could donate funds, to be held in perpetuity, for the benefit of this community and its citizens.

This organization became known as the Mission Community Foundation – a non-profit charitable organization for the benefit of the citizens of Mission.


Mr. Harris, together with others who had a similar vision, approached the then Dewdney Constituency M.L.A.s for their support. Austin Pelton and Norm Jacobsen sponsored Bill Pr404 and the Mission Foundation was born. Financial assistance during its early years was provided by the Mission Rotary and Kinsmen Clubs, McKnight Johnson and Partners and by the Founders: Norman Cook, G.W. Harris, Albert McMahon, Gordon Ruley, G.W. Walker, and John Weisgerber.

The first fund entrusted to the Mission Foundation came through the estate of the late Margaret Erskine in the amount of \$228,000 to support students pursuing post-secondary education. The Foundation has grown exponentially since then, thanks to the many incredibly generous donations made by community members.

The Mission Community Foundation is managed by a board of eleven. There are six elected volunteer members and five appointed members representing Mission City, Mission Public School District, Mission Regional Chamber of Commerce, Mission Community Services Society and Fraser Valley Regional District.

The Mission Community Foundation Board of Directors relies upon a professional team, including a Wealth Management Group, Bookkeeper, Auditor and Executive Director to provide advice, ensure legal requirements are met and to look after the day-to-day administration.





About Mission Community Foundation



Mission Community Foundation was founded on June 26, 1987, with monies donated through the estate of Margaret Erskine. Unlike other Foundations in BC and Canada, our Foundation was created by an Act of Parliament through a Private Members Bill. It serves the City of Mission and all areas included in School District #75's catchment.

It has representatives from the City of Mission, Mission Community Services Society, Mission Regional Chamber of Commerce, Fraser Valley Regional District, and School District #75, who sit on our Board of Directors with six (6) elected individuals. Together they manage the funds entrusted to the Foundation via Committee recommendations and a dedicated investment management team.

Colleen Hannah, worked alongside Lucas McKinnon, Bernadine Babuik and myself, to sit for 3 full days of 95 student interviews. 1 every 10 minutes. We had such amazing applicants, and even the ones that did not

receive a scholarship this year, should be very proud of themselves and we look forward to hearing all the success stories moving forward into the future. We were very proud of all the students. We were able to give out 91 scholarships in the amount of \$104500.00.

We saw 32 Middle school students receive Cooke Awards for excellence in Math and Science. So very proud of the students that can become future scholarship applicants.

We also had a very heartfelt Grant Cycle 1. We gave out more than \$87,500 to well-deserved community groups that had applied for so many needs in the community.

Grant Cycle 2 was \$78,100.00. Different applicants, but still the need is there in this community.

We want to thank the RBC investment team, Lonny, Nik, Mark, and Elijah. We could not do this work without your guided expertise and compassionate support, to get us to the best place, which is supporting this awesome community and of course us. HEPTONSTALL FAMILY FUNDS

In early 2020 Mission Community Foundation was advised that it was named the primary beneficiary of Jack Heptonstall estate. The estate consisted of 120 acres in a prime location in Hatzic Prairie and Jack left the Foundation his property with instructions to sell and create 6 funds from the proceeds. It was his desire to forever memorialize the family name in the community where he lived, with his sister Barbara, and loved all of his life.

Over the years the Heptonstall family was known for their community spirit. They were involved in the dairy board, diking board, schools, Rotary. The farm was also known as the place to go when there was a flood. They had the first tractor in the Valley and helped other farmers as time allowed.

During the 1948 flood many people moved their furniture and livestock to the Heptonstall barns as the land was above the flood levels. In 2021 when the Atmospheric River hit the Fraser Valley, the farm was called upon again to help the neighbours.

In 2023 the Mission Community Foundation received
