#### History

Mr. G.W. (Bill) Harris, a long-time Mission resident and former Mayor, recognized the need for an organization where Mission residents could donate funds, to be held in perpetuity, for the benefit of this community and its citizens.

This organization became known as the Mission Community Foundation – a non-profit charitable organization for the benefit of the citizens of Mission.

Mr. Harris, together with others who had a similar vision, approached the then Dewdney Constituency M.L.A.s for their support. Austin Pelton and Norm Jacobsen sponsored Bill Pr404 and the Mission Foundation was born. Financial assistance during its early years was provided by the Mission Rotary and Kinsmen Clubs, McKnight Johnson and Partners and by the Founders: Norman Cook, G.W. Harris, Albert McMahon, Gordon Ruley, G.W. Walker, and John Weisgerber.

The first fund entrusted to the Mission Foundation came through the estate of the late Margaret Erskine in the amount of \$228,000 to support students pursuing post-secondary education. The Foundation has grown exponentially since then, thanks to the many incredibly generous donations made by community members.

The Mission Community Foundation is managed by a board of eleven. There are six elected volunteer members and five appointed members representing Mission City, Mission Public School District, Mission Regional Chamber of Commerce, Mission Community Services Society and Fraser Valley Regional District.

The Mission Community Foundation Board of Directors relies upon a professional team, including a Wealth Management Group, Bookkeeper, Auditor and Executive Director to provide advice, ensure legal requirements are met and to look after the day-to-day administration.

# **About Mission Community Foundation**



Mission Community Foundation was founded on June 26, 1987, with monies donated through the estate of Margaret Erskine. Unlike other Foundations in BC and Canada, our Foundation was created by an Act of Parliament through a Private Members Bill. It serves the City of Mission and all areas included in School District #75's catchment.

It has representatives from the City of Mission, Mission Community Services Society, Mission Regional Chamber of Commerce, Fraser Valley Regional District, and School District #75, who sit on our Board of Directors with six (6) elected individuals. Together they manage the funds entrusted to the Foundation via Committee recommendations and a dedicated investment management team.

We, at the Mission Community Foundation, saw again many changes for the positive this year.

We said a fond goodbye and a huge thank you to Bernadine Babuik, who stepped into the role of ED for the transition period. With her expertise in Admin, we were in good hands. We also gave our appreciative goodbyes to board members, Erin Osterberg and Gurdeep Toor. We welcomed Julia Renkema to the Board of Directors.

We had discussions on Policy review and terms of reference moving forward at the Development Committee.

We retained Stephen Pomeroy again as Auditor and Red to Black bookkeeping for the year.

We cannot say enough kind words to our investment team. Lonny, Nik, Elijah, and Mark are so good at what they offer and do for us, and we can't thank them enough.

There was a move from the Lifetime Learners fund to gift spendable funds to the Mission Archives. We were saddened to hear that Lifetime Learners had to fold.

We also had \$ 335,120.63 in donations for the year 2024. We received \$300,0000.00 from the Prosperity Fund gifted to us through the Vancouver Foundation from a \$25 million multi-year program to community organizations in B.C.

We were lucky to have the Mission Chamber of Commerce offer the Foundation Directors a governance course that some attended this year, and we will be continuing this practice with all new members. Good professional development for anyone that sits at a Board table.

Applications flowed in from the students and adult learners. We had approximately 95 students (Grade 12) that came for interviews. Lucas, Shelley, and Linda interviewed for 2 full days at the School Board office.

We had a successful Cooke Awards/Scholarship evening at the Clarke Theatre. There were 36 Cooke Award recipients and 75 Scholarship recipients. \$152,000 was handed out for scholarships to 17 - 2nd Year/Adult students and 58 Grade 12 students. We must give a great big thank you and recognition to the many school staff and support staff that help the students fill out the applications for the scholarship process.

Both Grant cycles saw an increase in the number of applicants and the large need for support in this community, from food security, to supports in the classrooms, to Trades and community support to many other needs. We gave away \$73,208.00 for Grant Cycle 1 to 13 recipients and \$120,470 for Grant Cycle 2 to 18 recipients.

We would like to thank all the people that took the time to fill out the applications for their community groups with the 2 Grant Cycles we provide. These supports if successful make real changes in the City of Mission/FVRD and surrounding areas. We are again so very grateful to walk alongside all of you. Jamie Hayes came into the Foundation in the first week of March as newly employed Executive Director. We all welcomed her and knew she brought lots of expertise with her to promote the Foundation and to start the process of digitizing the operational side. We have a Marketing Working group that makes great recommendations to the board. Jamie is a valuable voice on this committee for spreading the info about the Foundation.

The Foundation sponsored the Rotary Gala for the first time, which was a successful event night, and both Rotary Clubs, Mission Morning and North Fraser came away with \$20,000.00 for each club to support many needs in the City of Mission.

Christine, Julia, Jamie, and I decorated a vehicle for the Mission Candlelight Parade and participated. Fun evening. Not too cold.

Over the year we attended and supported events around Mission - Rotary golf tournament, Mayor's luncheon, Candlelight Parade, School events, Folk Festival thank you breakfast, Rotary Gala, Investment appreciation night, Bollywood Gala, Vaisakhi event at UFV to name a few. We are a busy group.




# **MISSION & REGION PROSPERITY FUND 2024**
